### **Multiple Transaction**

#### **Documents:**

\$9.00 per each transaction

plus \$5.00 for each additional page.

1 Page with 2 document references = \$18.00

2 Pages with 2 document references = \$23.00

1 Page with 3 document references = \$27.00

2 Pages with 3 document references = \$32.00

1 Page with 4 document references = \$36.00

2 Pages with 4 document references = \$41.00

Plats of Survey are exempt from the new fee change. Plats are \$7.00 for the first page and \$5.00 for each additional page.

Section Corner documents are NOT exempt from the new fee change.
